- I have provided the most recent COE that I have received to the school certifying official and reported changes in my address.
- I must meet VA satisfactory progress standards to continue to be eligible for VA educational benefits.
- I consent to the release to the VA all of my student education records maintained by Vanderbilt University including but not limited to my social security number.
- I must complete this form each and every semester in which I wish to be certified for VA educational benefits.
- I understand that the VA considers the Doctor of Ministry program, Engineering Online programs, and Peabody Online programs to be distance programs, and have been informed that the effective Chapter 33 monthly housing allowance for students enrolled solely in distance learning is one-half the national monthly housing allowance.
