## Navigating the Degree Audit

- 1. Log in to <u>YES</u> using your VUnetID and e-password: <u>yes.vanderbilt.edu</u>.
- 2. Read and accept the Confidentiality Statement.

Confidentiality Statement
As a school official, you are authorized to access the academic records of students for whom you have an educational need-to-know. Your use of this application should be restricted accordingly. The data you will be viewing contains information protected by the Family Educational Rights and Privacy Act (commonly known as FERPA or the Buckley Amendment). 
